## What does the fund invest in?

The fund seeks income and long-term capital growth by investing primarily in fixed income and/or income-oriented equities issued anywhere in the world, although it currently invests primarily in North America. Depending on economic conditions and relative valuations by the fund's portfolio managers, the fund will generally invest 30% to 70% of its assets in each of equity and fixed income securities, but may invest up to 100% of its assets in either asset class. It may hold up to 30% in foreign investments.

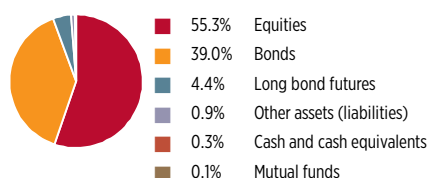

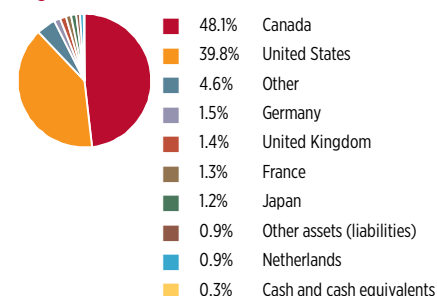

**How risky is it?**

The value of the fund can go down as well as up. You could lose money.

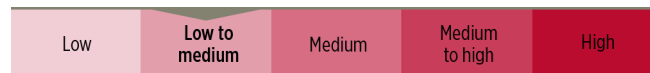
One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

**Risk rating**

CLIML has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns and the returns of the Predecessor Fund, Mackenzie Strategic Income Fund, the applicable series of which was reorganized into the corresponding series of the fund on September 17, 2021, have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

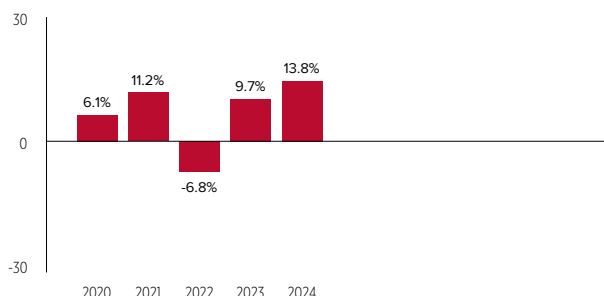
Like most mutual funds, this fund doesn't have any guarantees. You may not get back the amount of money you invest.

**How has the fund performed?**

This section tells you how F8 Series securities of the fund have performed over the past 5 years which is based on the performance of the fund's series and/or the applicable series of the Predecessor Fund, Mackenzie Strategic Income Fund, which was reorganized into the corresponding series of the fund on September 17, 2021. Returns are after expenses have been deducted. These expenses reduce returns.

**Year-by-year returns**

This chart shows how F8 Series securities of the fund performed in each of the past 5 years which is based on the performance of the fund's series and/or the applicable series of the Predecessor Fund, Mackenzie Strategic Income Fund, which was reorganized into the corresponding series of the fund on September 17, 2021. The fund dropped in value in 1 of the 5 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.

**Best and worst 3-month returns**

This table shows the best and worst returns for F8 Series securities of the fund in a 3-month period over the past 5 years. It is based on the performance of the fund's series and/or the applicable series of the Predecessor Fund, Mackenzie Strategic Income Fund, which was reorganized into the corresponding series of the fund on September 17, 2021. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

**Average return**

A person who invested \$1,000 in F8 Series securities of the fund since its inception would have had \$1,476 as of May 31, 2025. This is based on the performance of the fund's series and/or the applicable series of the Predecessor Fund, Mackenzie Strategic Income Fund, which was reorganized into the corresponding series of the fund on September 17, 2021, and is equal to an annual compounded return of approximately 6.9%.

**Who is this fund for?****Investors who:**

- are looking for an income-oriented balanced fund to hold as part of their portfolio
- want a medium-term investment
- can handle the volatility of stock and bond markets
- want to receive a monthly cash flow

**A word about tax**

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

**How much does it cost?**

The following tables show the fees and expenses you could pay to buy, own and sell F8 Series securities of the fund. The fees and expenses – including any commissions – can vary among series of a fund and among funds.

Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

**1. Sales charges**

You can only buy this series of the fund under the no load purchase option. No sales charges are payable by you under this purchase option.

## 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of March 31, 2025, the fund's expenses were 0.76% of its value. This equals \$7.60 for every \$1,000 invested.

### Annual rate (as a % of the fund's value)

#### Management expense ratio (MER)

This is the total of the management fee (including the trailing commission), fixed administration fee and fund costs.

CLIML waived some of the fund's expenses. If it had not done so, the MER would have been higher.

## 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch securities of the fund.

| <b>Inappropriate short-term trading fee</b> | A fee of 2% of the amount switched or redeemed will be charged by the fund for inappropriate short-term trading.                                                                                                                                                          |
| <b>Excessive short-term trading fee</b>     | A fee of 1% of the amount switched or redeemed will be charged by the fund if you invest in the fund for less than 30 days and your trading is part of a pattern of short-term trading that CLIML believes is detrimental to fund investors.                              |
| <b>F8 Series fee</b>                        | As part of your fee-for-service or wrap program sponsored by a Principal Distributor or Authorized Dealer, you will be required to pay your representative's firm directly an asset-based fee, which is negotiable.                                                       |

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund securities within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
